CALL FOR ABSTRACT PROPOSALS

The Academy of Physical Therapy Education (APTE) and the American Council of Academic Physical Therapy (ACAPT) hereby issue a call for educational session, platform and poster presentation proposals for the Educational Leadership Conference 2019. Abstracts will be accepted from March 15 until April 18, 2019. ELC 2019 will be held in Bellevue, WA October 18-20.

We invite academic administrators, faculty, and clinicians to engage with one another in the conference titled *Setting Sail: Discovering a New World of Opportunities* featuring the annual Dr. Geneva R. Johnson Forum on Innovation. Participants are encouraged to submit proposals that support excellence in the following sub-themes and topics:

 - Developing a Diverse and Culturally Competent Physical Therapy Workforce
 - Proliferation of Programs: Passport of Entry

Platform Presentations: Platforms will be 15 minutes for presentation time plus 5 minutes for question and answer discussions. Thus, the total time is no longer than 20 minutes. A platform may be presented by no more than two (2) authors.

Poster Presentations: Multiple poster sessions are provided throughout the conference. Each poster shall be presented by no more than two (2) of the author(s) during the scheduled poster session time frame. Poster dimensions are to be 3' feet in height x 4' or 5' feet in length.

Educational Sessions: Sessions are approximately 1.5 hours in length with opportunity for Q & A. The ELC Abstract Review Committee strives to select a balanced representation of abstracts to meet educational leadership programming needs for the intended audiences of academic and clinical faculty in physical therapist and physical therapist assistant education. We invite submissions focusing on one of the 4 themes that meets the needs of one or more of these audiences, for both clinic and classroom educational environments.

Please be aware that, although authors may submit more than one proposal, each author may submit up to two educational session as the primary author. We encourage all authors to limit their number of submissions to increase the diversity of topics and presenters. Only the first two primary authors will be considered for scheduling purposes.
